



## World Archery Judge Seminar

28-30 September 2018

World Archery Excellence Centre, Lausanne, Switzerland

**Scope:** Train continental judges endorsed by member associations towards World Archery international judge accreditation.

**Schedule:** Participants will arrive on 27 September 2018; the seminar will start on 28 September 2018 at 9h00 and conclude on 30 September 2018 at approximately 17h00. (Departure flights should be scheduled no early than 21h00.)

**Lecturers and examiners:** Morten B. Wilmann, (World Archery Judge Committee chairman), Sabrina Steffens and Robert Erica (members of World Archery Judge Committee).

The seminar will be conducted in English and run in parallel with a World Archery youth judge seminar.

**Applicants should include room requirements and expected flight details, along with a completed application form, signed by a member association and corresponding continental association.**

Applicants must possess the requirements listed in article 7.1.4 (book 1). In particular, they must be accredited as continental judges and have been accredited as national judges for at least three years, must have an adequate knowledge of English and must have served in at least one World Ranking Tournament (or a major tournament sanctioned by their continental association) with positive evaluation of the chairperson of the judge commission.

The application must be submitted to the World Archery Office according to article 7.2.4 (book 1). The application (signed by the applicant (the judge), their member association and their continental association) must indicate the personal information of the applicant (name, gender, birth date, nationality), languages spoken, dates appointed a national judge and continental judge, and their previous experience at world ranking tournament or equivalent level.

**Application forms must be signed by both a national member association and continental member association for the participant to sit the examination and receive any accreditation.**

Participants successful in the final examination will become a World Archery International Judge Candidate.

Participants must bring copies of the World Archery Constitution and Rulebook and World Archery Judge Guide Book – both available from the World Archery webpage [www.worldarchery.org](http://www.worldarchery.org) – and a magnifying glass.

Course numbers will be limited so member associations should prioritise applicants.
